"As a professional athlete, I have met thousands of people during my career," Harrison wrote in the affidavit, "but to the best of my knowledge and recollection, I have never met with the individual who is apparently named Charles Sly. ..."

Only Harrison has submitted a sworn affidavit.

The Al Jazeera documentary aired in December and sparked an investigation by the NFL. In "The Dark Side," Sly admits to an undercover reporter he is providing a substance named D2 or Delta-2 to Harrison.

Harrison's letter signals a high-profile standoff between the league and the NFLPA, which wants commissioner Roger Goodell to provide "credible evidence" before players agree to a face-to-face interview.

Retired future Hall of Fame quarterback Peyton Manning also was linked to PEDs in the Al-Jazeera documentary. The report alleged that Manning was given a supply of human growth hormone in 2011 from an Indiana-based antiaging clinic.

nounced his retirement following the Denver Broncos' victory in Super Bowl 50 in February, has no obligation to cooperate in the league's investigation as a retired player.

Manning has vehemently denied accusations he used human-growth hormone or PEDs during his recovery from neck surgery in 2011. Manning was not mentioned in the letter about the NFL investigation.

Sources have said that Manning likely will cooperate and submit to an interview with the NFL.

McIlroy lukewarm on golf's Olympic return | Paterno

TROON, Scotland Four-time major winner Rory McIlroy may not watch the golf event on television when it returns to the Olympics next month and hinted on Tuesday it was not one of the sports that would matter in Rio de Janeiro.

Unlike world No. 3 Jordan Spieth, who said earlier in the day that he agonized over his decision to withdraw from the Olympics, McIlroy said he was fully comfortable with his choice to opt out of golf's Games comeback after a 112-year absence.

"I don't think it was as difficult a decision for me as it was for him," the Northern Irishman told a news conference ahead of the 145th British Open that starts on Thursday.

"I'm very happy with the decision I made and I've no regrets about it. I'll probably watch the Olympics but I'm not sure golf will be one of the events I watch.

Asked which competitions he would view on television, McIlroy replied: "Probably the events like track and field, swimming, diving, the stuff that mat-

None of the world's top four golfers will play in Rio after Jason Day and Dustin Johnson also decided to opt

Fourth-ranked McIlroy said he did not feel as though he was letting his sport down. "I didn't get into golf to try and grow the game," explained the 27-year-old. "I got into golf to win championships, and major champi-

"All of a sudden you get to this point and there is a responsibility on you to grow the game, and I get that, but at the same time that's not the reason I got into golf.

"I didn't get into golf to get other people in the game but I get that...different people have different opinions.'

Those documents made public Tuesday also allege former Tampa Bay Buccaneers head coach and current defensive coordinator at Ohio State Greg Schiano told former Penn State defensive coordinator Tom Bradley in the early 1990s that he saw Sandusky "doing something to a boy in the shower.'

At the time, Schiano was the defensive backs coach for the Nittany Lions.

Schiano, on Tuesday, refuted former grad assistant Mike McQueary's testimony in those documents that allege some on Paterno's staff were aware of Sandusky's

"I never saw any abuse, nor had reason to suspect any abuse, during my time at Penn State," Schiano said, via Adam Schefter of ESPN. Bradley is the defensive

coordinator at UCLA. In a 2015 deposition, Mc-Queary testified when he told Bradley what he saw Sandusky doing to a boy in a shower, Bradley was "not shocked."

(Bradley) said he knew of some things," McQueary said. " ... He said another assistant coach had come to him in the early '90s about a very similar situation to mine, and he said that he had someone had to come to him as far back as the early '80s about Jerry doing something with a boy.'

Bradley's attorney also re-

futed McQueary's testimony. 'At no time did Tom Bradley ever witness any inappropriate behavior. Nor did he have any knowledge of alleged incidents in the 80's and 90's," lawyer Brett Senior said. "He has consistently testified as such. Any assertions to the contrary are false. When he became aware of the 2001 incident it had already been reported to the University administration years earlier.'



Sanduskv was convicted on 45 of 48 counts related to sexual assault on June 22, 2012, and was sentenced to 30 to 60 years in prison.

Paterno served as the Nittany Lions' head coach from 1966 until his retirement in 2011. He died on Jan. 22, 2012 at the age of 85.

Paterno's family issued a statement Tuesday saying, "The materials released today relating to Joe Paterno allege a conversation that occurred decades ago where all parties except the accuser are now dead.

"In addition, there are numerous specific elements of the accusations that defy all logic and have never been subjected to even the most basic objective examination. Most significantly, there is extensive evidence that stands in stark contrast to this claim."

Penn State President Eric Barron, in a statement on Tuesday said the university's "overriding concern has been, and remains, for the victims of Jerry Sandusky.'

Some have suggested the Browns cut Crowell, while others say he should be suspended. The team is more than just a little angry, according to reports. "It was completely inappro-

priate and we have made him aware of our high level of disappointment," the team said in a statement. "Isaiah has apologized but also knows that just an apology is insufficient and that he must take steps to make a positive difference after a very negative and impactful post.'
