French Cellar moves to new Machias location

MACHIAS — A few things have changed for Ryan French in the

past couple of months. In December, he left his job as manager of the Machias Hannaford so he could manage his family's business, the French Cellar, which features wine, craft beers and cheese. He did this so his parents, Rob and Betsy, could move to Halifax, Nova Scotia, for his father's job in shipbuilding.

As it turned out, he also ended up managing a nearly 14,000-square-foot, six-unit commercial building with four apart-

The French Cellar had been renting its location at 7 Water St. since Rob and Betsey French started the business in 2011. When Machias Savings Bank took ownership of the property last fall, the Frenches considered their options.

"We looked into buying the building, but it needs a lot of work," Ryan French, who lives in Cutler, said. Contractors told the family it would be cheaper to tear the building down than renovate it. So they decided to pass. Before they made plans to move

to another location, however, they learned Michael and Patricia Sansing were selling the commercial and residential building at 4 Colonial Way, where their business, Whole Life Natural Market, is located.

After doing their research, the Frenches decided it made financial sense to purchase the building and move their business to

the only empty commercial unit. Now the French Cellar is located next door to Whole Life. Other commercial tenants in the building include Columbia Falls Pottery, Coastal Soundwaves Music Store, Ray Foster Antiques & Fine Art and Susan West of Northwestern Mutual.

Patricia Sansing said the food market, which has been open since 2003, is staying put. She and her husband decided they no longer wished to own the building with all its rental units.

"We both work full time, and it's one less burden," she said, adding she was surprised the building sold so quickly. French said closing on the

itown aw Developer unveils renovation of former Dakin building in Bangor

The renovation of the long-vacant former Dakin Sporting Goods building overlooking downtown Bangor's West Market Square is complete after two years and a \$2 million investment.

On Friday, developer Roy Hubbard opened a trio of ground-level, loft-style apartment units at 28 Broad St. as a stop on the Downtown Bangor Artwalk.

"We put all this hard work into it and now we want to show it off," Hubbard said Friday night as people milled around munching on chicken wings and eyeing artwork mounted on the exposed brick walls of the apartments.

Originally, Hubbard planned to build retail space on the first floor, but based on the success he had filling the 15 upstairs units earlier this year, he decided to stick with residential.

"I was really impressed by the quality tenants we got and the excitement they had about being downtown," Hubbard said.

Hubbard said he recently started marketing the three new "super luxury" ground floor units, which are larger than the ones upstairs. Rent ranges from \$2,200 to \$2,500 per month. Most of the tenants are people from out of state who come to Bangor to work at the hospital or pursue a doctorate at the university. Others just want to be downtown.

The site has been largely vacant since

the late 1990s, when it briefly housed a coffee shop, cafe and TCBY vogurt shop. Since then, it has occasionally served as temporary headquarters for political campaigns.

In spite of several rounds of rehabilitation to the building's facade and an overhaul of its roof more than a decade ago, nothing significant happened in terms of development at the building until Hubbard purchased it from its former owner.

The address is the latest long vacant downtown Bangor structure to receive a sorely needed facelift and reuse. After decades of vacancy, the former Merchant's Bank building across the street opened last year with more luxury apartment units, and Evenrood's Restaurant on the ground floor.



Payday loans: Risk vs. reward

Just two weeks ago in this column we wrote about some debt collectors who bend rules or break laws. Last week, the Federal Trade Commission warned that some collectors are trying to capitalize on bogus payday loans.

A payday loan is a cash advance given to a consumer. The consumer hands over a check or agrees to have a **CONSUMER** deposit account debited. Either **FORUM**

transaction takes place at a future date when, the theory goes, the consumer can repay the loan plus interest.

Those short-term loans tend to carry high interest rates. In Maine, a supervised lender license is required, and lenders cannot charge more than \$25 on a loan of \$250 or more. If a consumer can't pay back the loan — often due in two weeks — it might be renewed, incurring another \$25 fee. If the loan were renewed every two weeks for a year, the consumer would pay \$650 in fees on that \$250 loan.

Unscrupulous lenders don't bother with licenses or with obeying the state and federal Fair Debt Collection Practices Acts. The FTC last week alerted state regulators nationwide that several companies either are trying to collect nonexistent loans or that they're trying to collect on loans that were never turned over to any third-party collector.

Gas prices rise 9 cents in Maine

PORTLAND — The average price of a gallon of regular gas rose about 9 cents in the past week, to put the statewide average back above \$2 per gallon.

The national price rose about 6 cents per gallon during the past week. As of Monday morning, the average national and Maine price for a regular gallon of gasoline landed at \$2.04, according to the price tracking website GasBuddy.

Patrick DeHaan, a senior analyst for GasBuddy, said the price increase is driven by refinery maintenance costs and a drop in gasoline reserves

"Until the bulk of refinery maintenance season wraps up in late May, we likely won't see the lower oil prices immediately bring relief to the pump as oil and gasoline inventories continue to move in the opposite direction,' DeHaan said, noting that crude oil inventories rose while gasoline reserves fell.
