

# Portsmouth drug death leads to sting, 2 arrests

PORTSMOUTH — After a 29-year-old man was found dead of a fentanyl overdose last year, a Portsmouth officer working as a federal agent tracked the fentanyl to Lawrence, Massachusetts, set up eight monitored drug buys in Lawrence and had two dealers arrested on secret warrants.

That's according to an affidavit filed with the U.S. District Court of New Hampshire for the arrests and prosecution of Rolando Sierra-Oyola, known as "Sample Dude," and Jose Oriol Feliz Aybar, both of Massachusetts and now charged with fentanyl trafficking to Portsmouth customers.

The eight undercover fentanyl buys were made on the streets of Lawrence starting in October 2015 and ending July 14, according to the affidavit by a Portsmouth detective currently assigned as a task force officer for the federal Drug Enforcement Administration. The officer's identity is not being reported at the request of police and to protect his safety.

The story begins Aug. 7, 2015, when Portsmouth police and firefighters were called to Riverbrook Condominiums in Portsmouth where the man was found dead of what was later cited by a medical examiner as from "acute intoxication by fentanyl and acetyl fentanyl," according to public records. Portsmouth detectives interviewed a witness, who identified as a heroin user and later agreed to work as a confidential informant, federal records state. A phone at the scene stored a number for "Sample Dude" who, the informant said, sold the fatal fentanyl to the deceased the prior evening, as well as to the informant for "a period of years," according to court records.

On Oct. 28, 2015, while monitored by police, the informant called Sierra-Ovola and made arrangements to meet in Lawrence to buy \$200 worth of heroin, according to court records. Wearing a wire to videorecord the deal, the informant paid with police-monitored cash for 5 grams "of a brown substance" that later tested positive as containing fentanyl.

A second buy of 10 grams of heroin for \$400 was arranged for Nov. 19, 2015, during a recorded transaction arranged by Sierra-Oyola to occur in a car in ment for addiction can Lawrence. Sierra-Oyola search for help at nhtreatwas not in the vehicle dur- ment.org.

ing the drug deal, the officer's report states and the 10-gram purchase was found to contain fentanyl, according to police. On Dec. 1 and 16, 2015,

worked with the undercover local officer to arrange recorded drug buys in Lawrence, both times for ten \$400 grams, police allege. The substances tested positive for fentanyl, according to the undercover officer's affidavit. On Jan. 27, a fifth "controlled purchase" of what

was purported to be 10 grams of heroin was arranged in Lawrence through Sierra-Oyola and the substance tested positive for fentanyl, the affidavit states.

The informant was monitored by police again on March 9 during a drug buy from Aybar in Lawrence, for a substance later determined to be cocaine and fentanyl, court records state. On April 21 and May 24, according to the local officer working the federal drug investigation, the informant bought \$400 "fingers" of fentanyl from Aybar, after arranging for the sales through Sierra-Oyola, federal records report.

The final police-monitored drug sale to the local informant, by the alleged Lawrence dealers, occurred July 19, again in Lawrence, police allege.

After the Portsmouth officer described all of the alleged monitored drug buys, in a sealed affidavit for the alleged dealers' arrests, Sierra-Oyola was arrested July 22, court records state. He was indicted July 27 by a federal grand jury for a charge alleging conspiracy to distribute and possession with intent to distribute controlled substances, court records show. He's scheduled for a trial in the U.S. District Court of New Hampshire, with jury selection scheduled to commence Sept. 7.

Abar, his alleged accomplice, is charged with the same federal crime. After the accused dealers' arrests last month, the federal court unsealed the case records.

New state law grants immunity to anyone reporting a drug overdose and law enforcement across the country is treating addicts with leniency and compassion. Drug dealers remain targets of law enforcement.

### 2 killed in Maryland explosion and fire

WASHINGTON — Two people were killed and several remained missing after an explosion and fire tore through an apartment complex overnight in a Washington suburb, authorities said on Thursday.

The blast and fire just before midnight at the four-story complex in Silver Spring, Maryland, injured 34 people, including three firefighters. All the firefighters were treated and released.

reportedResidents smelling gas just before the blast, Montgomery County Executive Ike Leggett said at a news conference. The explosion was felt more than a mile away and tossed debris as far as 300 feet, fire officials said.

Two bodies were found in the building rubble but police were unable to complete a search because the site needed to be shored up, according to Montgomery County Assistant Police Chief Russ Hamill.

Washington Gas, a unit of WGL Holdings Inc, which provided service to the complex, said in a statement it was helping in the investigation.

About 160 firefighters battled the blaze, which was brought under control after about two hours. Television footage showed flames and smoke pouring from the building as fire-fighters rescued a man from an upstairs apartment window.

Agents from the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) were helping local fire investigators. ATF experts are routinely sent to help in investigations of major fires, an agency spokesman said.

Clothing was strewn on sidewalk treetops in video footage provided by fire officials. Bricks were launched across a roadway, badly damaging a storefront and
