

ANSWER: Partner may have only a five-card suit, hence you mustn't raise the hearts. To leap to 3NT might work, but he could hold a six-card heart suit or weakness in clubs. Bid two spades. If partner next bids 2NT or three clubs, try 3NT. If he bids three diamonds, bid three hearts to show a tolerance for that suit.




