NOTICE OF INTENT TO FILE

Please take notice that Winterport Marine and Boat Yard, Inc. of PO Box 130, Winterport ME 04496 is intending to file a Natural Resources Protection Act permit application with the Maine Department of Environmental Protection pursuant to the provisions of 38 M.R.S.A. §§ 480-A thru 480-BB on or about February 15, 2015.

The application is for two piers (one 6' x 50', the other 6' x 70' pile supported piers to form a straddle lift launching and hauling ways). Distance between the piers is 16'-9" at the following location: 49 Water Street, Winterport ME 04496.
