Take guesswork off your family's plate with advance planning





If we have lived long enough, we eventually probably experience the death of loved ones. It is always hard, whether expected as in the case of someone who has been ill for a long time, or sudden, such as a massive heart attack or other unexpected occurrence. Planning a funeral or service during this stressful time has completely drained more

been long time friends with Jim Fernald, Brookings-Smith, so I reached out to have my questions

"When you pre-arrange, you make those first 24 hours easier for your loved ones," said Fernald. "You can also save the family money. Often, the stress of making last-minute funeral arrangements causes people to make unnecessary purchases, but by taking care of the arrangements yourself, you free them from spending more than they need too.

Not easy to think about, to be sure. "Hey, Honey, let's go plan our funerals and then go to lunch to celebrate," is not a conversation I would look forward to. And yet, I recalled a conversation I had with a friend awhile back shortly after her husband passed away after a long illness. She explained to me how they had gone to the funeral home together and had pre-planned and pre-paid for everything. She admitted that, even though emotional, it was the best thing they could have done and that for the first time in a week she had gotten a full night's sleep.

"It wasn't easy, but I knew that when the time came, all I'd have to do is make a phone call," she said. "It was a relief to know that financially it was taken care of and that I wouldn't be planning while in a grief stricken state. More importantly, I know that my husband would get the funeral he wanted. His wishes were met and he had peace of

mind knowing that I wouldn't have to deal with it at the end of his

And according to Fernald, there are plenty of details to attend to — more than 70 in the first 24 hours after a death. That is a lot to think about in a short amount of time. Pre-planning ensures decisions are made in advance, when you have time to think, added Fernald.

"And pre-planning can be everything from a few of notes on a slip of paper to having every minute detail arranged, right down to the hairstyle of the deceased," he said. "Pre-arranging tells your loved ones exactly how to celebrate your life and honor your memory. It can be as much or a little as you need it to be."

Have you given any

thought as to how you want to be remembered? Did you have a military career you want celebrated? Or maybe you love animals and would like to encourage donations in your memory to a shelter. The point is, it is all up to you.

And then there is cost. Funerals can be expensive, no doubt about it. And while it feels cavalier to think about money at a time like this, trust me, you will get sticker-shock if you look at prices.

Well, like most things, funeral costs tend to rise every year," said Fernald. "That means a funeral today will probably cost less than the same funeral three or four years from now. Paying for your funeral now can save your loved one's money. We discuss with people how to lock in rates."

The most important thing is how the survivors cope after the fact and having a funeral that truly

honors the person, while reducing the stress on the family both emotionally and financially, is the best endorsement for pre-planning.

"Funerals provide closure and help the loved ones move on," said Fernald. "We quite often get nice thank you notes on the service we provided. We are here to make a hard situation a little easier so knowing we helped someone means the world
